2. No competitor will be allowed to compete where it appears that such a person has used, or is under the influence of, any alcohol or illegal drug or medicine. Any competitor found in possession of any alcoholic beverage, illegal drug, or narcotic substance at the tournament site may be disqualified from the tournament.
3. All competitors will be required to appear for competitions at the posted times. Any person who fails to appear when the division is called, or who fails to appear when their name is called in their division, may be disqualified according to Liberty Classic and HKA rules.
4. All competitors must wear clean white or black karate Gi (uniform).
5. All entries are final upon registration.
6. Statement of health: by my and/or parent/guardian’s signature below, I confirm that I am in sound health and there is no reason why I cannot participate in this tournament and/or event.
